Level III: RedAddibration & Creation of a Stable Biomechanical Foundation

Two Day Session

For most patients with TMD or Occlusal Disease issues, definitive occlusal treatment is more beneficial than occlusal splint therapy. In Level III, you apply the concepts and methods of Levels I & II to do this. However, this is not about doing a conventional equilibration. Rather, it is about the concurrent utilization of Reductive and Additive reshaping (RedAddibration) to establish occlusal harmony at any chosen Vertical Dimension of Occlusion - to create a Stable Biomechanical Foundation.

In non-restorative cases, a Stable Biomechanical Foundation is the end point of treatment. In this situation, it represents the most predictable and conservative definitive treatment for the vast majority of patients suffering with TMD or Occlusal Disease. This is the most common application of RedAddibration in most offices and is the preferred application to begin learning this process.

In this hands-on course, you learn the clinical skills needed to actually perform a RedAddibration. Under the watchful eye of an instructor, you will perform a live RedAddibration on a patient of your own that you have previously evaluated with a DATA Appliance and for whom you have Verified and Validated casts. In Level III, the RedAddibration is performed on a patient who does not require extensive restorative or aesthetic treatment and represents the end point of their treatment.

From Level III, You Will Learn How To:

- Identify patients who are or are not good candidates for RedAddibration,
- Choose the most appropriate Treatment Path based on their patients' Problem Profile, psychosocial status and wants and needs,
- Choose the most appropriate Vertical Dimension of Occlusion (VDO) for patients with non-restorative Treatment Paths,
- Use a combination of reductive & additive reshaping to definitively achieve this VDO & create a Stable Biomechanical Foundation, and
- Make RedAddibration one of the most rewarding and profitable procedures you perform in your office
